### Practice Schedule and Details

- Practice will begin at the beginning of November and will end with the AAU Nationals in June.
- The primary practice location is the Faith Lutheran gym: 2727 S. Grove Street, Eustis, FL 32726.
- When the Faith Lutheran gym is not available, our secondary location is Round Lake Charter School gym: 31333 Round Lake Rd. Mount Dora, FL 32757.
- Practices are typically on Tuesday and Thursday from 7 pm - 9 pm however they may vary at times due to gym availability.
- Practice days may vary 1-2 weeks a season due to travel requirements for travel teams and coaches. These weeks will be noted in the practice calendar provided at the beginning of the season.
- Special practice days may be added on designated Fridays in November and December for position training. For these weeks, there will be three practice nights. These practice nights are covered in your club fees.
- A practice calendar will be provided in advance.
- All plans are subject to change due to any state/national mandates related to COVID or other COVID-related situations.

This payment is non-refundable as the items cannot be returned.</li></ul>	<ul style="list-style-type: none"><li>● \$550</li><li>● Due August 15th - 20th</li><li>● This payment is non-refundable as this payment covers annual expenses incurred such as equipment, club member website access, coach's AAU/USAV memberships, SportsRecruits membership, and annual club membership fee.</li></ul>	<ul style="list-style-type: none"><li>● \$380</li><li>● Due the 1st - 5th of each month</li><li>● These payments cover coach's salary, coach's travel expenses, facility rental, insurance, tournament entry fees, recruiting assistance, administrative and office expenses. A portion of these payments may be refundable if ST7 is mandated to close for the season due to the pandemic or other unforeseen situation.</li></ul>

**After viewing the information above, if you would like to commit to the team and ST7 Volleyball for the 2023 - 2024 Club Season, there are a few steps to complete in order to secure your spot on the team and commit to the season.**

### Commitment and First Payment

**Step One:** Read the Parent/Athlete Handbook in its entirety. It is vital that you read and decide if you are comfortable committing to the policies found within. To view the handbook: [Click Here](#)

**Step Two:** Once you have completed reading the handbook and you have decided that you are comfortable committing to the season, you will need to electronically sign the Statement of Commitment by 9:00 pm on Friday, 7.21.23. Your signed Statement of Commitment will serve as your acknowledgment that you have read through the entire handbook and are agreeing to abide by the rules and policies found within. If you have any questions about what is found in the handbook, please reach out to us immediately. Please note that if you choose to sign the Statement of Commitment without reading it in its entirety, this will not excuse any consequences for violations of the policies found within. We will have a mandatory parent/athlete/coach meeting at the beginning of the season. The date and time for the meeting will be announced later. To sign the Statement of Commitment: [Click Here](#)

**Step Three:** If you are committing to the season your signature on the Statement of Commitment will act as your notification to ST7. \*If you have decided to not commit to the season, please email us at [st7volleyball@gmail.com](mailto:st7volleyball@gmail.com) to let us know.

**Step Four:** In order to accept an athlete's commitment the first payment of \$550, must be paid by Saturday, 7.22.23. This commitment payment will cover the cost of the athlete's uniform package. An electronic Quickbooks invoice will be sent by email once the letter of commitment is signed. Payment may be made by bank transfer or credit card. \*Please note, if using a credit card there is a service fee of \$18 for this payment.

**Step Five:** On Sunday, July 23rd, ST7 will publish the list of committed athletes. A committed athlete is defined as an athlete who has completed signing their letter of commitment by July 21st and paid their commitment fee by July 22nd. Once committed, athletes will need to attend a uniform sizing, provide further documents, and join AAU and USAV. Further details for these steps will be provided.

**Step Six:** Committed athletes will need to attend a uniform fitting so that we can order their uniform. [We have the following dates available for uniform fitting: July 24th, 25th and 26th from 9:30 am - 11:30 am at Round Lake Charter School.](#)

**Step Seven:** Upon commitment, athletes will need to complete more documents and obtain the appropriate memberships for their team. We will provide a list of documents and memberships necessary for each team and athlete at a later date. AAU memberships are approximately \$14 and USAV memberships are approximately \$55. **Please do not purchase your memberships yet as they will expire before the season even begins.** We will notify you by email when you should purchase your memberships.
